# Objective, Baseline & Target

---

**Objective:** To increase the percentage of CTAE pathway completers earning a national industry recognized credential or a passing score on an end of pathway assessment.

**Baseline:** SY 2012-13: 36% pass rate

**Target:** By SY 2016-17:  $\geq$  50% pass rate

# EOPA Background Information

---

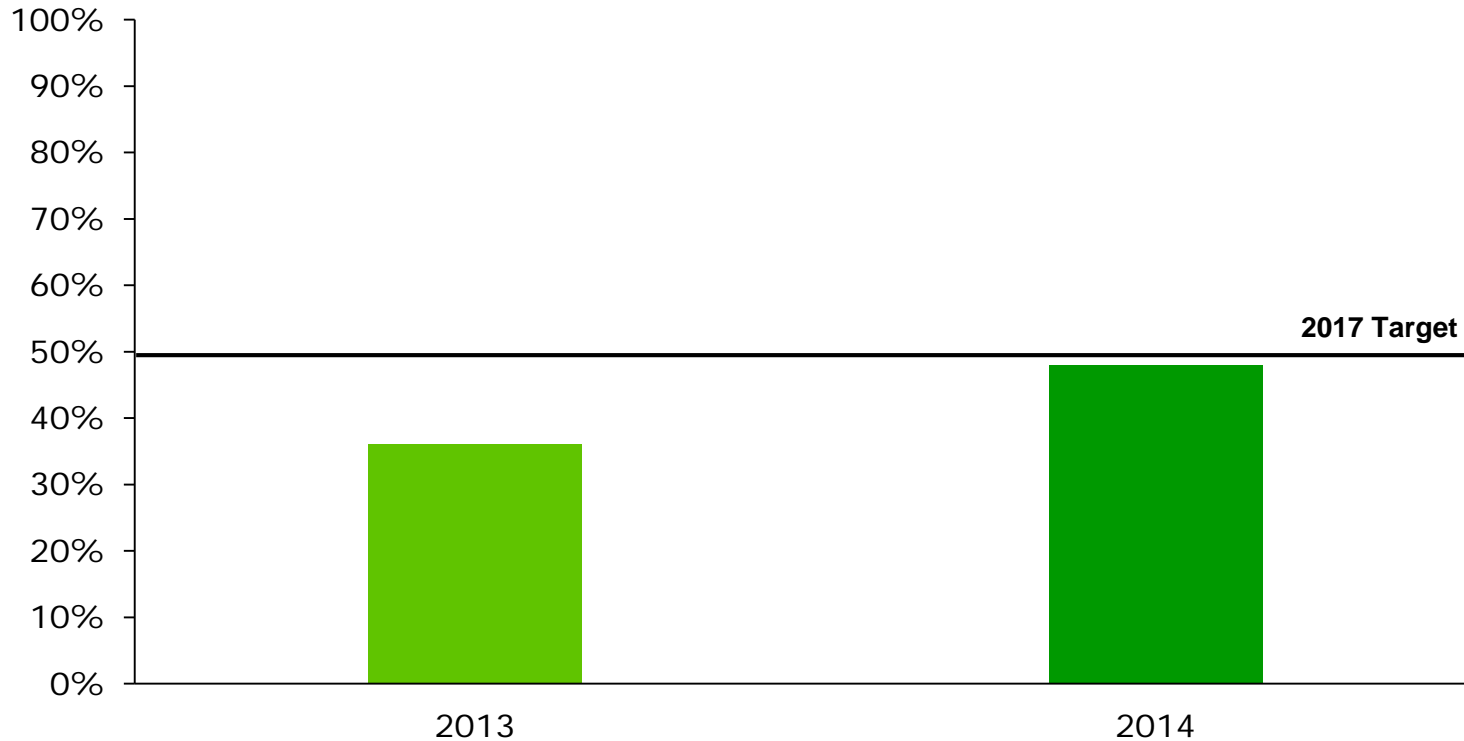
- ❑ The End-of-Pathway Assessment provides students with opportunities to earn industry-validated credentials while still in high school.
  
- ❑ Available EOPAs include over 100 different exam options.
  
- ❑ EOPAs include varying types of exams/certifications, including:
  - Industry-Recognized Credentialing Exams
  - Occupational Assessments
  - State Licensing Exams
  - State-Developed Occupational Assessments

# EOPA Background Information

---

- ❑ Students become eligible for the EOPA when they reach pathway completer status, defined as follows:
  - Have successfully completed the three or four designated courses in the pathway, OR
  - Are enrolled in the final designated third or fourth course of the pathway and are on track to complete it successfully
  
- ❑ Students may take the EOPA exam multiple times, however, only those who complete the pathway and pass the exam within the same year are reported in the official EOPA data collection.

# Action Items

---

- The Director of College and Career readiness in collaboration with the Executive Director of Secondary School Governance will monitor the formative data, meet with the school leadership to analyze results, and recommend individualized instructional delivery adjustments to ensure program effectiveness.
- The Director of College and Career readiness in collaboration with the Executive Director of School Secondary Governance will implement an electronic walkthroughs/observation protocol which allows for effective monitoring of teacher performance based on End of Pathway Assessment (EOPA) standards.
- The Office of College and Career Readiness will provide professional development and support to high school teachers in order to increase the number of certifications earned through the new Business and Technology Pathway using Microsoft IT Academy.

# Data Criteria

---

- End of Pathway Assessment (EOPA) data is received from GADOE and reported based on the official state EOPA data collection.
  
- Per GADOE reporting requirements:
  - EOPA data reflect only those students reported in the official data collection as having attained pathway completer status and passing the EOPA in the same reporting year.
  
  - Students at program sites (including part-time Woodville-Tompkins students) are attributed to the attendance zone school.
